 - b. "Automotive Recyclers" means all persons who and entities which purchased a Subject Vehicle, as defined below, containing a Takata Inflator, as defined below, and that currently engage in, or at the time of such purchase were engaged in, the business of automotive salvage or recycling, or that recycled, refurbished, or removed for sale or re-sale, second-hand Takata Inflators or Takata Inflator-related component parts.
 - c. "Takata Inflator" or "Takata Inflators" mean Takata PSAN inflators, which are all airbag inflators for driver- or passenger front airbags which Takata manufactured and sold containing propellant with Phase-Stabilized Ammonium Nitrate ("PSAN"), including 2004 and 2004L propellant, whether desiccated or non-desiccated.
 - d. To submit a claim for a Settlement Benefit, you must submit a Claim Form to Car-Part.com, BMW's Settlement Claims Administrator, by going to www.recyclerpayment.org to download additional Claim Forms.
- 2. The deadline for submitting a Claim Form is two years from the date of implementation. Current date of implementation is anticipated to be December 6, 2023, but this date may move. Please periodically check the settlement website (www.recyclerpayment.org) for updates.
